range of NWQROC priorities. Several relate to prior commitments and continuing works which will support the North West's economic recovery. Increased funding for specific areas of roads and water infrastructure have not been forthcoming but with increased QTRIP funding to be considered in next budget. There are no specific future investment commitments undertaken around land management, and biodiversity. The commitment to continue Works for Queensland is most welcome as well as a specific undertaking to continue working with NWQROC on identified priorities including water infrastructure.

KAP Katter's Australian Party has strongly supported road, water and power initiatives in train and given a welcome commitment to the establishment of a North Queensland Future fund tapping into the State Government's \$5 billion Queensland Future Fund to identify and build key priorities in the North. Specific support for key North West priorities from this fund has not been indicated. Meaningful initiatives for indigenous communities in housing have been identified as well as support for LGAQ's Advancing of First Nation Councils.


LNP The LNP has provided a broad level of support for NWQROC priorities including a welcome commitment to continuing Works for Queensland. Consideration to increasing QTRIP and TIDs is also welcomed together with moves to increase council workforce access to roadworks on State controlled roads. Undertakings to address housing shortages and support biosecurity, pest and weeds management initiatives will be welcomed across the region. The \$1billion Queensland Investment Partnerships, would be open to councils and receive project proposals involving tourism, housing, water, and technology. Support for increased access fibre optic infrastructure is also welcomed.

The response received, focusses solely on the irrigation developments, specifically chemicals used in large scale irrigation and the subsequent impacts to the meat and livestock sector. Mr Scriven supports smaller scale irrigation farming.

On 28 August 2020, the North West Queensland Regional Organisation of Councils wrote to each of the major parties and independent candidate contesting the election seeking a response on the priorities that will help communities across North West Queensland grow and prosper.

Queensland Labor, Katter's Australian Party, Liberal National Party and Independent Craig Scriven have each responded. Our assessment of their response has formed the basis of our scorecard below.



"The Palaszczuk Labor Government has put Queensland on the road to recovery by making strong decisions on the border and starting to deliver our economic recovery plan. We acknowledge the productive working relationship the government has had with NWQROC and the role NWQROC's eight local governments have played in delivering services to Queenslanders and driving regional economies."

"While many economies around the world are still shut down because of the global pandemic, the Palaszczuk Labor Government's strong health response has ensured that we're able to focus on our economic recovery."

"Mr Katter said he was committed to putting Traeger in the driving seat when it came to bolstering the economy in the wake of COVID-19, with key investments in water, power, health and living affordability."

"The major parties have been heavily-criticised for their lack of a COVID economic recovery plan, but the KAP is ahead of the game and has already mapped out a robust strategy to fuel huge growth in Traeger."

"I am committed to endeavouring to acknowledge and address a wide range of issues affecting Traeger and believe everyone should felt heard in helping shape the future of North Queensland and beyond."

"It should be acknowledged that the public balance sheet alone cannot dig Queensland out of trouble. The state will urgently need the support of the private sector to get the recovery going. This is the reason we have committed to a no new tax guarantee to encourage private sector investment in projects all across the State."

"It is our contention that Queenslanders want a plan to stimulate the economy and provide a decade of secure jobs – and that is what the LNP will deliver. Our commitment to building a stronger economy will enable more investment in the initiatives being sought by NWQROC."

"The LNP will work collaboratively with NWQROC and its member Councils in a strategic partnership approach towards the economic recovery of the region."

"I was extremely encouraged to hear an interview with the Cloncurry Mayer (sic) regarding the use of treated water for an irrigation project at the local racetrack. I believe they have a 1Mgl/day output, and to put that into perspective with irrigation, 1Mgl of water equals 100mm of rain per Ha."
